It is intimated that the site, measuring 21 Kanal 12 Marla, comprising of khasras nos. 58//23/2, 59//8, 9/1, 11/1, 11/2, 12, 13, 18/1, 19/1, 20/1 falling in the revenue estate of Village - Seria, Tehsil - Beri, Distt-Jhajjar, does not fall in any Controlled Area declared under the provisions of the Punjab Scheduled Roads & Controlled Areas Restriction of Unregulated Development Act-1963. The site falls in the Urban Areas of Beri, but there is no violation of the Haryana Development and Regulation of Urban Areas Act, 1975. This information is given subject to the following conditions:-
